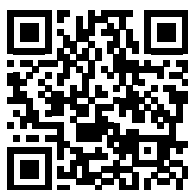

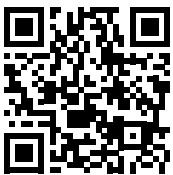
Free Wi-Fi is available throughout the venue.
